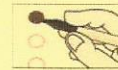
Official Ballot for Coordinated Election Lincoln County, Colorado Tuesday, November 7, 2017

Instructions to Voters:

1. Mark your ballot with blue or black ink.
2. If you make a mistake, either request a replacement ballot from your County Clerk and Recorder, or cross out any errors and add a note making very clear the voting choice you intend to vote.
3. To vote for a named candidate, completely fill the oval to the left of your choice. Vote like this:



WARNING: Any person who, by use of force or other means, unduly influences an eligible elector to vote in any particular manner or to refrain from voting, or who falsely makes, alters, forges, or counterfeits any mail ballot before or after it has been cast, or who destroys, defaces, mutilates, or tampers with a ballot is subject, upon conviction, to imprisonment, or to a fine, or both. Ballot questions referred by the general assembly or any political subdivision are listed by letter, and ballot questions initiated by the people are listed numerically. A ballot question listed as an "amendment" proposes a change to the Colorado constitution, and a ballot question listed as a "proposition" proposes a change to the Colorado Revised Statutes. A "yes/for" vote on any ballot question is a vote in favor of changing current law or existing circumstances, and a "no/against" vote on any ballot question is a vote against changing current law or existing circumstances.

Ballot Issue 3A

School General Obligation Bond for High School Renovation

SHALL CROWLEY COUNTY SCHOOL DISTRICT RE-1J DEBT BE INCREASED UP TO \$3.5 MILLION, WITH A REPAYMENT COST OF UP TO \$5.9 MILLION AND SHALL DISTRICT TAXES BE INCREASED BY UP TO \$300,000 ANNUALLY, FOR GENERAL OBLIGATION BONDS THE ISSUANCE OF WHICH IS SUBJECT TO A GRANT AWARD OF STATE FINANCIAL ASSISTANCE FOR NOT LESS THAN TWO-THIRDS OF THE TOTAL PROJECT COSTS UNDER A "BEST" GRANT AND OTHER POSSIBLE GRANTS PRIOR TO DECEMBER 31, 2020, TO FINANCE THE:

- RENOVATION OF THE HIGH SCHOOL, AND TO THE EXTENT OF AVAILABLE FUNDS THE UPDATING AND IMPROVING OF SCHOOL BUILDINGS (SUCH AS VOCATIONAL AGRICULTURE, WRESTLING ROOM, FOOTBALL LOCKER ROOMS AND WARD BUILDING) TO EXTEND THEIR USEFUL LIFE AND TO ADDRESS HEALTH, SAFETY, SECURITY, AND EDUCATIONAL DEFICIENCIES IN THE DISTRICT'S SCHOOL FACILITIES;

WHICH GENERAL OBLIGATION BONDS SHALL BEAR INTEREST, MATURE, BE SUBJECT TO REDEMPTION, AND BE ISSUED AT SUCH TIME, AT SUCH PRICES (AT, ABOVE OR BELOW PAR) AND IN SUCH MANNER AND CONTAINING SUCH TERMS, NOT INCONSISTENT HERewith, AS THE BOARD OF EDUCATION MAY DETERMINE; AND SHALL AD VALOREM PROPERTY TAXES BE LEVIED IN ANY YEAR, WITHOUT LIMITATION AS TO THE MILL RATE TO PRODUCE AN AMOUNT SUFFICIENT IN EACH YEAR TO PAY THE PRINCIPAL OF AND INTEREST ON SUCH DEBT?

Ballot Issue 3B

School Funding Override for General Fund

SHALL CROWLEY COUNTY SCHOOL DISTRICT RE-1J TAXES BE INCREASED \$248,000 ANNUALLY (SUCH DOLLAR AMOUNT BEING THE FIRST FISCAL YEAR INCREASE) AND THEREAFTER BY WHATEVER AMOUNTS ARE RAISED FOR A LIMITED TEN-YEAR PERIOD FROM AN OVERRIDE MILL LEVY IMPOSED AT A RATE OF UP TO SIX (6) MILLS IN ORDER TO RESTORE A PORTION OF THE STATE CUTS IN THE DISTRICT'S OPERATIONAL FUNDING, WHICH MONEYS SHALL BE USED FOR EDUCATIONAL PURPOSES TO INCLUDE, AMONG OTHER THINGS:

- REPLACING OUTDATED TEXTBOOKS AND EDUCATIONAL MATERIALS,
- IMPROVING STUDENT ACCESS TO UPDATED TECHNOLOGY,
- REPLACING OLDER BUSES AND SCHOOL VEHICLES BASED ON SAFETY AND CONDITION, AND
- IMPROVING THE LEVEL OF MAINTENANCE OF SCHOOL FACILITIES,

WITH SUCH INCREASE TO COMMENCE IN COLLECTION YEAR 2018 AND SUNSET AUTOMATICALLY AFTER COLLECTION YEAR 2027, AND WITH SUCH TAXES TO BE IN ADDITION TO THE PROPERTY TAXES REQUIRED BY STATUTE TO BE LEVIED FOR THE GENERAL FUND BUT SHALL NOT EXCEED ANY STATUTORY LIMITATION ON ADDITIONAL LOCAL REVENUES?
