The Board of Lincoln County Commissioners met at 9:00 a.m. on April 8, 2013. The following attended: Chairman Ted Lyons, Commissioners Greg King and Doug Stone, County Administrator Roxie Devers, and Clerk to the Board Corinne M. Lengel. County Attorney Stan Kimble attended in the afternoon.

Chairman Lyons called the meeting to order and asked Ms. Devers to lead the Pledge of Allegiance, after which the one bid received for work on the fairgrounds grandstands was opened and reviewed. After ensuring that all items listed in the Scope of Work were addressed in the actual bid, Mr. Stone made a motion to accept the bid in the amount of \$45,460 from Gene Amann for work on the fairgrounds grandstands. Mr. King seconded the motion, which carried unanimously. Funds for the project will be taken from the Conservation Trust Fund.

Mr. King made a motion to approve the minutes from the meeting held on March 29, 2013, as submitted. Mr. Stone seconded the motion, which carried unanimously.

Mr. King then made a motion to cancel County General check #22421 in the amount of \$5,970.60 and Road & Bridge check #22457 in the amount of \$274.58, both written on March 6, 2013, to K.C. Electric since they were not received. Mr. Stone seconded the motion, which carried unanimously.

The Board reviewed the March 2013 Treasurer's and Sheriff's reports, and then Mr. Stone made a motion to approve the contract between the Lincoln County Sheriff's Department and Lincoln Community Hospital for medical services for jail inmates. Mr. King seconded the motion, which carried unanimously.

Mr. Lyons reported receiving a phone call from Gary Withington on April 1 concerning the noise from the wind tower, and Mr. Lyons told him that he felt there was nothing more the county could do, concerning how Mr. Kwolkoski's reports came out. Mr. Lyons also checked roads and oil wells on that same day and again on April 5. Before he could finish his report, Matt Mosher and Julie Joffe arrived for their 9:30 appointment.

Mr. Mosher said he would like to make some changes to the way the stripping chute works and would like to move it to the north side of the bucking chutes, which would also help out Glen Southwick, who provides the rodeo stock. Ms. Joffe added that the stripping chute needs to be raised up as it has sunk down over the years, so they would like to do it all at one time. Mr. Mosher said that if the county would pay for any pipe or materials they might need, he and Daryl Waite will do the work. Mr. Lyons said he didn't really see a problem, but that he would prefer if the suggestion was brought before the fair board on May 14 prior to any of the work being done, just to make sure they had no issues with it.

Mr. Stone said he'd spoken with Kenny Book, who felt that moving the chute would eliminate the "sorting" or "return" alley, and perhaps even one of the pens in the area where stock is sorted, and they need all the pens they can get. Mr. Mosher said that wouldn't happen with

the plan he has in mind and he hopes to make access easier around the corner also. He added that he has no intention of changing the return alley.

Mr. Lyons asked him to draw up his proposal and share it with the fair board on May 14, and Mr. Mosher said he would be happy to.

Ms. Joffe wanted to let the Board know that a bill will eventually come through from Shawn Smith as she asked him to pour some concrete over by the south concession stand where the water valve broke last fall. They had to remove the slab of concrete to get to the valve and now it won't fit back in the same spot. She contacted Shawn who told her that he would pour some concrete when he has a job in the area.

Ms. Joffe also wanted to clarify that the commissioners do want both the VFW band and the Shriner's band in the fair parade, since they will cost \$300 each, and was told that they do.

The meeting was then adjourned until 1:00 p.m. so that the commissioners could attend the Eastern Transportation Planning Region meeting in Limon.

When the meeting reconvened at 1:00 p.m., Mr. Lyons finished his report by stating that he had spoken with Kerry Halde about prospective oil wells, and Travis Nall about moving some of the downspouts on the courthouse. He also mentioned that something definitely needs to be done with the courthouse parking lot, especially the west side, even if it has to be done in sections.

Mr. Stone reported checking on the road crew on April 1 while they were putting in a tube on the Blue Cliff road, and receiving a call from Barney Burch on April 2 regarding several cattle guards filled with dirt, which he blamed the blade operator for. On April 3, Mr. Stone checked the cattle guards in question and agreed that they are definitely in need of cleaning out. He asked the other commissioners if they allow their road crews to clean out cattle guards and Mr. Lyons said they have taken a backhoe and done it before, as long as the cattle guard is easily lifted out.

Mr. King reported checking roads and going by the Genoa shop on April 1, as well as attending the Economic Development Corporation meeting. They will write a contract with Vickie Maxon who already has a list of current businesses that she wants to visit and see what LCEDC can do for them. Mr. King also mentioned meeting with the East Central COG board. On April 2, he received a call from Gary Withington about the noise of the wind tower, as well as a call from Rob Raines who is concerned with the number of seismograph crews on the county roads. He also commented that Limon is applying for a Foreign Enterprise Zone, and Travis Taylor learned that there is a total of twelve inches of dirt in the stock show arena when barrel races are held; eight inches for other events. They had talked at the last fair board meeting about the amount of dirt that should be in the arena, so Travis said he would find out what they do at the National Western Stock Show.

Ms. Devers said that she had typed up the contract with Gene Amann for the Board to sign, requesting that he begin work on the grandstands no later than April 22. She stated that, in the past, the county has charged a \$250 per day penalty if the work is not completed on time.

Mr. King made a motion to appoint Bobbie Jaques to the Bookmobile Board to fill the vacancy left by Dolle Lehrkamp. Mr. Stone seconded the motion, which carried unanimously.

Ms. Devers reported that Vickie Miller will be using the Outback Express bus to transport dental patients from Limon to Flagler while Plains Medical Center is being remodeled. PMC will pay her salary and will fill the bus with fuel after each trip. The commissioners had no problems with the arrangement.

Ms. Devers asked if the Board wanted to have a free day at the landfill again this year, which they do. Mick Jaques suggested May 18 with an alternate weather date of June 1, and the commissioners agreed with the dates.

Ms. Devers also reported that CDOT approved the request to increase the minimum self-performed requirement for the contractor doing the roundhouse doors and windows, and then stated that the Board needed to discuss replacing the courthouse roof jacks and sewer vents damaged in the July 2012 hail storm. The previous board had decided the work would be done, but Ms. Devers said that since it is too much for Travis Nall, they will need to request bids.

The Electronic Recycling Jobs Act, which is effective July 1, 2013, creates several requirements for the landfill and alternatives to be in compliance. Ms. Devers said what that means is that it will soon be illegal to place computers, fax machines, printers, televisions, and other related electronics in a landfill. If the county does not have an electronic waste recycling program, or at least two events per year where electronics can be disposed of, the county can request an exemption, as long as they make a good faith effort to comply. Ms. Devers asked if she should check to see if there is a company willing to provide an "electronics dumpster" at the landfill for this purpose, or if the commissioners would prefer to take the exemption. Mr. King said he felt they should do one or the other, as he felt people may start dumping their items in ditches if there isn't a place to dispose of them. Ms. Devers will do further research.

Ms. Devers updated the Board on SB13-169 – Introduction of Black-Footed Ferrets without further legislative approval if the landowner consents to programmatic safe harbor agreement. She said that Senator Greg Brophy and Representative Tim Dore are both supporting the legislation.

At 1:30 p.m., Public Health Director Sue Kelly met with the Board to give her monthly report. Phases IV and V (Capacity Assessment and Prioritizing) have been completed in regard to the Community Assessment (CHAPS) and calculations were done to determine the interest and ability of existing organizations in Lincoln County to address those issues that most concern county residents and that show room for improvement according to CDPHE data. The two top issues for Lincoln County are mental health/substance abuse and tobacco use.

Ms. Kelly reported that she and Bill Rusher both took part in the Mass Casualty exercise in Hugo on March 12 as part of their Healthcare Coalition, which also helped them to meet one of their deliverables for this year's EPR contract. As for Vital Records, Ms. Kelly said that the audit information has been sent in as required, but they have not received any results back yet.

Public Health is continuing to receive payment for the flu shots from Anthem Blue Cross, and have learned how to bill Rocky Mountain Health Plans. Upon follow-up of their Medicare billing submitted in late January, they found an error, which they have corrected and resubmitted. Ms. Kelly said she will wait another week and then follow up again.

The Scope of Work/action plan and proposed budget (\$19,741) submitted for the "Tobacco Use in Youth Project" was accepted and will run from July 1, 2013, through June 30, 2014. Also, Public Health has been notified of a newly-diagnosed case of latent (non-contagious) TB, and they are working closely with PMC and the state to obtain treatment for the individual.

Lincoln County has been designated a "Bookend County" by the Reach Out and Read program., meaning that all healthcare providers are participants in the program, which is a pretty big deal according to Ms. Kelly, as there is only one other in the entire state. She also informed the commissioners that Lincoln County has been ranked 14<sup>th</sup> of 64 Colorado counties in public health indicators, which is an extremely positive ranking. Finally, Ms. Kelly said that the FRMS (Financial Risk Management System) six-month follow-up audit was completed and the new ranking achieved is "low risk". The next audit will be done in another twelve months.

Ms. Kelly asked about the Karval water issue and Ms. Devers responded that she had finally called Kelly Alvarez who contacted someone that called the engineer in the water management district. She added that hopefully the situation has been resolved, at least for now.

At 2:00 p.m., Human Services Caseworker Mimi Lyons met with the Board to discuss Differential Response, which is a more family-oriented way of investigating child abuse. The entire state will be adopting differential response over the next three years, and it will require extensive training, including different types of interviewing skills and a completely different way of meeting and working with the families. Ms. Lyons commented that it will be very good for families who may have just had one incident that should not be classified as child abuse; something that could ruin a life if the incident were to be reported in the current manner. Training in May will require two community members, and Ms. Lyons asked if one of the commissioners would consider attending the two-day training. Mr. Stone said he would attend. Ms. Lyons added that she wanted the Board to be aware that there may be more time on the employee time sheets, as they would need to work weekends, evenings, and holidays to meet with people in regard to this new program.

Ms. Devers asked Mr. Kimble to look at a letter that the commissioners had received, but after reading it, Mr. Kimble said that the letter writer would have to contact the 18<sup>th</sup> Judicial District, as the commissioners have no jurisdiction over employees of the courts, D.A.'s office, or Probation.

Mr. Kimble then reported on the letter he had sent to the commissioners concerning a request from Peakview Energy Company to place a disposal water line under the county right-of-way. Paul Abbey with Peakview Energy Company sent a letter to the commissioners requesting a "franchise" from the county to construct or install disposal water lines in, under, or alongside the county right-of-way.

Mr. Kimble said that adjoining landowners own the fee to the center line of a public road, and while other uses of the road are subservient to the county's use of the right-of-way as a county road, he does not believe that the county has the authority to grant a franchise or to grant any ancillary use of a county right-of-way. He did cite several state statutes that give uses of county rights-of-way to certain entities such as electric, gas, or pipeline, water and sanitation districts, and telecommunication companies. However, the county can regulate where the utilities are located and require removal if necessary to keep the road maintainable and safe. He finished by saying that he did not see that disposal water lines are a use that would be given favorable treatment under the statutes he cited, and since the underlying property is actually owned by the adjacent landowners, it would be best for the company to negotiate with those adjoining landowners and locate the pipeline adjacent to the county right-of-way. Finally, he added that if the county allowed such an event to take place once, he felt they may be setting a precedent for future issues. Ms. Devers will compose a letter from the commissioners and have Mr. Kimble review it.

The commissioners approved the remaining expense vouchers for the month of March 2013.
