- ◆ Parents
- ◆ Grandparents and Great Grandparents
- ◆ Stepparents
- ◆ Siblings
- ◆ Spouse
- ◆ Ex-Spouse with proof of direct and tangible interest
- ◆ Adult children, stepchildren or grandchildren of the deceased
- ◆ In-laws, aunts, uncles, nieces, nephews, cousins if it is needed to administer the deceased's estate or other direct and tangible interest
- ◆ Legal representative of the deceased
- ◆ Funeral Director
- ◆ Employer of decedent so benefits can be processed
- ◆ Insurance company processing decedent's claim or death benefits
- ◆ Probate researchers
- ◆ Genealogists representing immediate family members with appropriate credentials
- ◆ Creditors
- ◆ Others who may demonstrate a direct and tangible interest when information is needed for determination or protection of a personal or property right
- ◆ Informant listed on the requested death certificate
